Japan	<p>* For cosmetics, it is only allowed to send 24 single pieces to the same address and of which should be personally use (within 2 months usage) and non-alcoholic</p> <ul style="list-style-type: none"> • All plants, herbs and related products • Gunpowder (including match, lighter, disposable body warmer, etc.) <p>* Inspection time for video tape and new film takes a long time and it is suggested to be handcarried</p> <ul style="list-style-type: none"> • According to Japan's "Food Sanitation Act", all tableware and related products can only be delivered to individual customers with residential addresses, also quantity limits for individual use only. <p>* Since Japan Customs cannot provide a standard quantity for the above, any parcels with tableware and related products may be stopped by the Customs; Customs may request shipper to provide photos of the items and proof for individual use for submission to Ministry of Health, Labour and Welfare for checking and confirmation</p>

Shanghai	<ul style="list-style-type: none"> • For all personal non-documents shipments, YAMATO can provide international delivery services for such products, however, consignee has to take care of the customs clearance in Shanghai, YAMATO will provide all the corresponding information and documents needed to the consignee in advance. • Handwriting invoice is not allowed. It is necessary to provide consignee telephone number. • The consignee should be a registered corporation in the country and acquired necessary import permission. • The products under regulation of "China Compulsory Certificate" <p>* It is prohibited to perform any business activities (e.g. distribution, export and import, for sales or usage, etc.) without CC certificated from an authorized representative.</p> <p>Products such as Microwave, Rice-cooker, mobile phones, laptops, electric wires, must have CC certificate in order to be delivered.</p> <p>For more details regarding CC Certificate, please go to http://www.ccc-cn.org/</p> <ul style="list-style-type: none"> • If shipment's value is higher than USD\$45, the shipment will be subject to Duty and Export Declaration Fees and related tax. If shipment's value is higher than 5000 Yuan, the shipment will be considered as high value goods and which the customs clearance procedure may take longer. • For non-document shipment, CR code (10 figures for import / export registration code), and HR code (Category analyzing code) are needed. For delivery to individuals, consignee has to take care of the customs clearance in Shanghai. • Used clothes (Delivery will only be available to individuals, and cosignees must handle the customs clearance in Shanghai). • Memory devices such as CDs and memory sticks, can be delivered only if it is for promotional, training, or commercial purpose. If shipping volume over 200 must have registered the "administration of import of audio and video products". • Food, Cosmetics, Chemical items
